This matter being opened to the Court by Greg D. Shaffer of Wilentz, Goldman & Spitzner, a New Jersey attorney and the attorney of record for Plaintiffs *Bernice Aquino, et al.*, to permit Richard P. Kinnan of Engstrom, Lipscomb & Lack, an attorney admitted to the practice of law in the State of California, to participate with other counsel for *Bernice Aquino, et al.*, in all phases of the trial, and it appearing Richard P. Kinnan is a licensed attorney in good in the State of California and it appearing that, pursuant to R. 1:21(a)(3)(i), there is good cause for my admission on the Plaintiffs' behalf. This is a product liability - design defect claim in which I am very familiar. I am representing multiple plaintiffs in this type of litigation, which litigation involves claims that Plaintiffs suffered injuries as a result of using the Mirena® IUD, a drug manufactured by defendant Bayer Healthcare Pharmaceuticals, Inc., which resulted in Plaintiffs


suffering damage to their uterus and other internal organs, and Plaintiffs have also suffered unspecified amount in economic damages My knowledge of and familiarity with this type of litigation makes me particularly qualified to assist in preparation and prosecution of this matter.

It is on this 27th day of May, 2015, ORDERED that Richard P. Kinnan be and hereby is admitted *pro hac vice* and is authorized to appear and participate with other counsel for Plaintiff in all phases of the trial, subject to the following conditions:

1. Richard P. Kinnan shall abide by the New Jersey Court Rules including all disciplinary rules, R. 1:20-1 and R. 1:28-2.
2. Richard P. Kinnan shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his agent upon who service of process may be made for all actions against plaintiff that may arise out of his participation in this matter.
3. Richard P. Kinnan shall immediately notify the court of any matter affecting his standing at the Bar of any other jurisdiction.
4. Richard P. Kinnan shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.
5. Richard P. Kinnan cannot be designated as trial counsel.
6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of inability of Richard P. Kinnan to be in attendance.
7. Richard P. Kinnan must, within ten (10) days, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit an affidavit of compliance.
8. *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2.

9. Non-compliance with any of the terms of this order shall constitute grounds for removal.

10. A copy of this Order shall be served on all parties within seven (7) days of the date hereof.
