**ORDER GRANTING  
ADMISSION *PRO HAC VICE* TO  
STEVE FARIES, ESQ.**

**THIS MATTER** having been brought before the Court by Andrew J. D'Arcy, Esq., of the law firm of D'Arcy Johnson Day, P.C., on a Motion for an Order granting admission *pro hac vice* to Steve Faries, Esq.; and the Court having read the moving papers and the opposition thereto, if any; and having considered the arguments of counsel; and for good cause shown;

IT IS on this 5<sup>th</sup> day of August, 2015

**ORDERED** that pursuant to R. 1:21-2, Steve Faries, a member of the Bar of the State of Texas, be and hereby is admitted to practice *pro hac vice* on behalf of the plaintiff named above; and it is further

**ORDERED** that during the term of his admission *pro hac vice*, Steve Faries shall:

1) abide by the Rules of the Court for the State of New Jersey, including all disciplinary Rules;

2) consent to the appointment of the Clerk of the Supreme Court as an agent upon whom

service of process may be made for all actions against him or his firm that may arise out of his participation in this matter;

3) notify the Court immediately of any matter affecting his standing at the bar of any other court; and

4) have all pleadings, briefs and other papers filed with the Court signed by an attorney of the firm D'Arcy Johnson Day, P.C., who shall be held responsible for them and for the conduct of the cause and of the admitted attorney therein; and it is further


**ORDERED** that Steve Faries shall not be designated trial counsel in these matters pursuant to R. 4:25-4, nor shall any delay in discovery, motions, trial or any other proceeding occur or be requested by reason of his inability to be in attendance at same; and it is further

**ORDERED** that automatic termination of Steve Faries' *pro hac vice* admission will occur for failure to make the required annual payment to the New Jersey Lawyers Fund for Client Protection; and it is further

**ORDERED** that noncompliance with any of the requirements of this Order shall constitute grounds for revocation of admission; and it is further

**ORDERED** that the Clerk of the Court shall forward a copy of this Order to the New Jersey Lawyers Fund for Client Protection; and it is further

**ORDERED** that a copy of this Order shall be posted online to all counsel of record within seven (7) days.
