

Van de Kieft as admitted herein; and it is further,

**ORDERED** that Christopher M. Van de Kieft shall make a payment to the New Jersey Fund for Client Protection as provided by New Jersey Court Rules R.1:20-1(b) and R. 1:28-2 and submit an affidavit of compliance; and it is further,

**ORDERED** that a copy of this order shall be served on all parties within seven (7) days of the date hereof.
