This court, on September 27, 2017, having entered Case Management Order 28 in the above-referenced matter which, among other things, set a Pre-Trial Schedule as to the Moore action (Case No. BER-L-018156-14), which required the filing of pretrial motions and related matters pursuant to a schedule agreed upon by Plaintiffs' liaison counsel and counsel for Defendants, including the filing and exchanging of all briefs and motions no later than November 8, 2017, and counsel for Plaintiff Moore having failed to submit and/or serve any brief/motion in connection with the trial of the Moore action,


**NOW THEREFORE**, on this 13<sup>th</sup> DAY of November, 2017, this court **ORDERED** that:

1. All briefs/motions on behalf of Plaintiff Moore shall be served and filed no later than November 17, 2017. In the event Plaintiff Moore fails to comply with the terms of this order, it shall be precluded from filing any motions related to the trial of the matter, including, but not limited to, motions for summary judgment, in limine motions, motions challenging any of Defendants' experts or motions related to the trial of the matter.

2. Except as modified by the order, the Pre-Trial Schedule set forth in the Case Management Order of September 28, 2017 shall remain in full force, namely,

a. Pre-Trial Schedule:

- i. Parties will exchange all deposition designations on November 17, 2017.
- ii. Opposition briefs will be filed by November 30, 2017.
- iii. Reply briefs will be filed by December 11, 2017.
- iv. Parties will exchange witness lists and exhibit lists by December 4, 2017.
- v. Parties will exchange objections and counter-designations by December 8, 2017.
- vi. Arguments on motions will be on dates to be designated by the court.
- vii. Jury questionnaire proposals to be submitted by December 15, 2017.
- viii. Statement of the case for the jury to be submitted by December 15, 2017.
- ix. Parties to exchange objections to counter-designations and counter-counter designations by December 22, 2017.
- x. Jurors complete questionnaires and hardship requests to be addressed on January 15, 2018.
- xi. Deposition Designation disputes to be held January 16, 2018.
- xii. Additional jurors complete questionnaires as necessary and remaining hardship requests to be addressed on January 17, 2018.
- xiii. Jury Charges will be submitted by January 19, 2018.
