STIPULATION OF DISMISSAL


THIS MATTER, having been opened to the Court by Plaintiffs, through their counsel Cohen, Placitella & Roth, P.C., and Defendants, through their counsel Shook, Hardy & Bacon, LLP, seeking an Order of Dismissal With Prejudice as to Plaintiff Rodger Karr's Loss of Consortium Claim (as asserted in the Master Long Form Complaint) and seeking an Order of Dismissal Without Prejudice as to all remaining claims against C.R. Bard, Inc., Sofradim, Covidien, Ltd., Tissue Science Labs, Ltd., and John Does 1-20 (collectively, "Defendants"), by consent of the undersigned, dismissing all claims against Defendants, and for good cause shown;
