ORDER OF DISMISSAL


This matter, having been opened on the court's motion and for good cause shown,

Bard, Inc./Covidien, counsel for Bard/Covidien shall file a stipulation of dismissal with prejudice within 20 days after the release and/or settlement agreement is received by Bard/Covidien.

IT IS FURTHER ORDERED that within fourteen (14) days of the date of this Order, defense counsel shall serve a copy of this Order on counsel for plaintiffs for the matters listed on Schedule A.
