
**CONSENT ORDER VACATING DISMISSAL

 PELVIC MESH MASTER DOCKET**

THIS MATTER having been opened to the Court by application of Plaintiffs, Peggy McAllister and Michael Patrick McAllister for an Order vacating The Honorable James J. DeLuca, J.S.C.'s September 29, 2017 dismissal without prejudice due to Plaintiffs' participation in a proposed global resolution, and reinstating their Complaint to the In re: Pelvic Mesh / Bard Litigation, Master Docket No. BER-L-17717-14 as a result of their removal from the global resolution group, and the Consent of the attorneys for Defendant, C.R. Bard;

IT IS on this 10th day of October, 2018;

In the event the matters are not resolved, counsel for the respective plaintiff(s) shall notify the court in writing for further direction.”
