IT IS on this 9 day of Sept, 2013,

ORDERED that Bard's Motion for the Admission of Kevin G. Lohman, Esq., *pro hac vice* is hereby **GRANTED**; and it is

FURTHER ORDERED that Kevin G. Lohman, Esq. of Reed Smith LLP, 355 South Grand Avenue, Suite 2900, Los Angeles, CA 90071, be and hereby is, admitted to the bar of the Supreme Court of the State of New Jersey for the purpose of representing Bard before this Court in the *Vigil* matter, ATL-L-6917-10; and it is

FURTHER ORDERED that Kevin G. Lohman, Esq. shall:

1. Abide by the New Jersey Rules of Court, including all disciplinary rules;
2. Consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against her that may arise out of her participation in this matter;
3. Notify the Court immediately of any matter affecting her standing at the bar of any court; and
4. Have all pleadings, briefs and other papers filed with the Court signed by an attorney of record authorized to practice in New Jersey, who shall be responsible for her and for the conduct of the cause; and it is


FURTHER ORDERED that the admission of Kevin G. Lohman, Esq. is subject to any conditions imposed by the judge hearing the trial of this matter; and it is

FURTHER ORDERED that the admission of Kevin G. Lohman, Esq. shall not in any way delay the trial of this matter, nor serve as the basis for any application for adjournment of trial of this matter; and it is

FURTHER ORDERED that Kevin G. Lohman, Esq. will make all required payments to the New Jersey Fund for Client Protection within ____ days hereof and shall annually comply with R. 1:20-1(b) and R. 1:28-2 during the period of his admission; and it is

FURTHER ORDERED that the Clerk of the Court shall forward a copy of this Order to the Treasurer of the New Jersey Fund for Client Protection; and it is

FURTHER ORDERED that a copy of this Order shall be served upon all counsel within seven (7) days of the date of this Order.
