Order to Reconcile Active Case Lists and
Provide updated PFS**
All prior orders remain in full force and
effect except as modified by this Order.

THIS MATTER having been reassigned to the Bergen County Vicinage, from Atlantic County, pursuant to the Supreme Court's Order of October 31, 2014; the Court having conducted a Case Management Conference; counsel appearing; for good cause shown and for the reasons set forth on the record;

IT IS on this 20th day of April, 2021, **ORDERED** as follows:

1. Within ten days of the entry of this Order, all Plaintiffs' Counsel are to review the Spreadsheet Charts attached hereto as:
 - a. Exhibit A (Multi-manufacturer List), purporting to identify active, eligible cases in which a manufacturer other than Ethicon/Johnson & Johnson has been named as a party (whether in addition to, or without an Ethicon entity), with "eligible cases" being defined to include

active cases that were filed prior to January 15, 2021, which have not settled with the non-J&J/Ethicon manufacturer and are not subject to a Master Settlement Agreement with the non-J&J/Ethicon manufacturer.

A case subject to a Master Settlement Agreement, where the Plaintiff has been or will be provided a settlement offer, but has not yet rejected or confirmed non-acceptance of the settlement offer, is not deemed an eligible case until the Plaintiff rejects/chooses not to accept a settlement offer pursuant to that Master Settlement Agreement),¹ and

- b. Exhibit B, purporting to identify all eligible cases,² defined to include active cases filed prior to January 15, 2021 that have not settled with Ethicon/Johnson & Johnson directly or pursuant to a Master Settlement Agreement with Ethicon/Johnson & Johnson. A case subject to a Master Settlement Agreement, where the Plaintiff has been or will be provided a settlement offer, but has not yet rejected or confirmed non-acceptance of the settlement offer, is not deemed an eligible case until the Plaintiff rejects/chooses not to accept a settlement offer pursuant to that Master Settlement Agreement.³

2. The review is to determine if any cases listed should be added, deleted or edited to correct inaccurate information, reflect that the case is no longer active as to a particular party (whether due to settlement, dismissal or other reason),

¹ Exhibit A reconciliation shall include the obligation to denote in a separate column on the spreadsheet whether the plaintiff has rejected a settlement allocation offered.

² In the context of Exhibit B, “eligible” shall not include cases involving a currently marketed Ethicon TVT product wherein the plaintiff has not had a revision surgery.

³ Exhibit B reconciliation also shall include the obligation to denote in a separate column on the spreadsheet whether the plaintiff has rejected a settlement allocation offered.

update/correct/remove any case listed that does not meet the eligibility criteria, or if any eligible cases not listed need to be added to the list.

3. Any discrepancies identified are to be itemized by plaintiffs' counsel in detail, including an explanation, and emailed to aslater@mazieslater.com, kjcrawford@riker.com; fhenry@riker.com; renright@riker.com within 10 days of the entry of this Order. Discrepancies, updates and corrections may be conveyed by making redlined changes, comments or explanations within a copy of the spreadsheet itself.
4. Thereafter, by April 20, 2021, the parties shall meet and confer to resolve discrepancies.
5. The Court will address any unresolved issues regarding the reconciliation of the active case list, including any unresolved decision as to whether any settlement rejecter plaintiffs shall not be included in the next set of discovery pools, and intends to commence selection of additional discovery pools for trial work up following submission of the updated spreadsheets in May, 2021.
6. Each plaintiff with a case that remains on Exhibit B after April 30, 2021, regardless of whether it has been selected as a discovery pool case, shall serve by June 1, 2021 (in accordance with the Ethicon PFS Service protocols):
 - a. a certified, updated Plaintiff Fact Sheet ("PFS");
 - b. updated executed medical records authorizations;
 - c. product implant sticker;
 - d. implant operative report; and
 - e. operative report(s) for any revision procedure; or

f. if applicable in lieu of 6(a)-(e), above, a certification that no changes or updates are required to the PFS, authorizations or other documents.
