CASE MANAGEMENT ORDER #84

All prior orders remain in full force and effect except as modified by this Order.

THIS MATTER having been reassigned to the Bergen County Vicinage, from Atlantic County, pursuant to the Supreme Court's Order of October 31, 2014; the Court having conducted a Case Management Conference; counsel appearing; for good cause shown and for the reasons set forth on the record;

IT IS on this 14th day of June 2022, **ORDERED** as follows:

I. CASE ACTIVATION – CASES WITH REVISION SURGERIES

- A. All cases on the attached Exhibit X shall be and are hereby activated for discovery.
- B. Any counsel who believes that there is a basis to exempt a case from discovery activation shall notify both liaison counsel (aslater@mazieslater.com and k Crawford@riker.com) by July 11, 2022 with a detailed explanation as to why. The Court will make a determination as to whether the case can be exempt from discovery.¹
- C. In all of the cases identified on Exhibit X, plaintiff shall serve by August 30, 2022 (in accordance with the Ethicon PFS Service protocols²):
 - a. a certified, updated Plaintiff Fact Sheet (“PFS”);
 - b. updated executed medical records authorizations in the forms attached hereto as Addenda A;

- c. product identification stickers for all products/devices implanted to treat either SUI or prolapse, regardless of whether Plaintiff is making a claim in this civil action related to that product/device;
 - d. implant operative report; and
 - e. operative report(s) for any revision procedure.
- D. If applicable in lieu of Paragraph I(C), above, counsel may serve by August 30, 2022, a formal certification executed by the plaintiff (not counsel) that there are no changes or updates that are required to the PFS, authorizations and/or other documents and that attaches a copy of the most recently served PFS to which it is certified there are no changes or updates.³ If records authorizations were last sent over six months prior to the date of this Order, even if sent undated as required by the protocols, the new forms of authorizations must be executed and exchanged.
- E. Plaintiffs who fail to *timely* comply with Paragraph I(C) or I(D) may have their complaint dismissed.
- F. No depositions shall be scheduled until there has been full compliance with Paragraph I(A) through I(D). If, in response to a request to schedule a deposition, defenses counsel asserts that there are insufficient records to proceed with depositions, defense counsel shall notify plaintiff's counsel and the parties shall promptly meet and confer to resolve the issue.

II. CASE ACTIVATION – CASES WITH ZERO REVISION SURGERIES

- A. All cases on the attached Exhibit Y shall be and are hereby activated for discovery as of September 6, 2022.
- B. Any counsel who believes that there is a basis to exempt a case from discovery activation shall notify both liaison counsel (aslater@mazieslater.com and kcrawlford@riker.com) by September 20, 2022, with a detailed explanation as to why. The Court will make a determination as to whether the case can be exempt from discovery.⁴
- C. In all of the cases identified on Exhibit Y, plaintiff shall serve by October 14, 2022, (in accordance with the Ethicon PFS Service protocols):

- a. a certified, updated Plaintiff Fact Sheet (“PFS”);
 - b. updated executed medical records authorizations in the forms attached hereto as Addenda A;
 - c. product identification stickers for all products/devices implanted to treat either SUI or prolapse, regardless of whether Plaintiff is making a claim in this civil action related to that product/device;
 - d. implant operative report; and
 - e. operative report(s) for any revision procedure.
- D. If applicable in lieu of Paragraph II(C), above, counsel may serve on October 14, 2022, a formal certification executed by the plaintiff (not counsel) that there are no changes or updates that are required to the PFS, authorizations and/or other documents and that attaches a copy of the most recently served PFS to which it is certified there are no changes or updates.⁵ If records authorizations were last sent over six months ago, even if sent undated as required by the protocols, the new forms of authorizations must be executed and exchanged.
- E. Plaintiffs who fail to *timely* comply with Paragraph II(C) or II(D) may have their complaint dismissed.
- F. No depositions shall be scheduled until there has been full compliance with Paragraph II(A) through II(D). If, in response to a request to schedule a deposition, defenses counsel asserts that there are insufficient records to proceed with depositions, defense counsel shall notify plaintiff’s counsel and the parties shall promptly meet and confer to resolve the issue.

III. SETTLEMENT

- A. The Court continues to engage in settlement conferences consistent with the **12/1/2021 Settlement Conference Order**. If any plaintiff not identified specifically in that Settlement Order wishes to engage in settlement discussions, the following is the minimum required information that must be provided:

- 1) Provision of the information required by paragraphs I(C) or I(D) above (as applicable); and
 - 2) all medical records in their possession, custody or control relating to plaintiffs' implant with an Ethicon pelvic mesh device and all treatment related thereto (including revision and explant records) to be sent to NJPFS@butlersnow.com, dgantert@riker.com, wcarlucci@riker.com; fhenry@riker.com, and Donna.Erter@butlersnow.com.
- B. Only after a plaintiff's counsel is in a position to comply fully with Paragraph II(A), may counsel contact Defense Liaison Counsel, kcrawlford@riker.com to be put in contact with Ethicon Settlement Counsel.
