A. Expert Discovery

 Plaintiff expert report(s) shall be served by July 19, 2024. If Plaintiff fails to serve all expert reports by the deadline without having obtained prior leave of the Court, the case may be dismissed with prejudice.

- Defense expert reports shall be served by September 19, 2024.
- (iii) The parties shall make best efforts to complete all necessary plaintiff expert depositions by October 18, 2024, and all necessary defense expert depositions by November 18, 2024. Defense expert depositions will not be conducted until after completion of plaintiff expert depositions.
- (iv) Expert discovery shall be completed by November 18, 2024.

B. Pre-Trial Motions

- (iii) Only when necessary, on leave of Court, limited replies shall be filed and served by January 28, 2024.
- (iv) Oral argument on pre-trial motions shall commence on a date to be determined by the Court.
