**THIS MATTER** having come before the Court via Plaintiffs' and Defendants' Liaison Counsel; for good cause shown and for the reasons set forth on the record;

IT IS on this 1<sup>ST</sup> day of DECEMBER, 2023, **ORDERED** as follows:

**I. SCHEDULING ORDER FOR CMO 74 CASES**

**A.** This Order section applies to the following CMO 74<sup>1</sup> cases:

1. TVT Exact (Gauldin)
2. TVT Exact (Mays)
3. TVT Exact (Snyder)
4. TVT-Secur (Wilcox)

**B. FACT DISCOVERY** – Except as otherwise governed by CMOs 95 (regarding friends/ family) and 97 (regarding sales reps), any outstanding fact discovery will be completed by January 15, 2024.

**C. EXPERT DISCOVERY**

1. In order to facilitate compliance with the deadlines in this Order, by January 15, 2024, Plaintiffs are to advise Defendants if the plaintiff has or intends to submit to an IME by plaintiffs' case specific expert, and provide possible dates between February 12, 2024 and March 15, 2024 when the plaintiff can attend an IME to be conducted by the Defendants' experts. Defendants will then send plaintiffs' counsel an email confirming the name of the defense expert, his or her qualifications, the location, date and time of the IME. This information will then be formalized in a Notice for IME that complies with the New Jersey Court Rules. If Plaintiff objects to any aspect of the proposed IME, those objections can be raised with the Court by letter if there is no resolution after meeting and conferring with Defendants.
2. Plaintiffs' expert reports shall be served by February 5, 2024. If Plaintiffs fail to serve all expert reports by the deadline without having obtained prior leave of the Court, the case may be dismissed with prejudice.
3. Defendants' expert reports shall be served by March 25, 2024.
4. The parties shall make best efforts to complete all necessary plaintiff expert depositions by May 8, 2024, and all necessary defense expert depositions by June 13, 2024. Plaintiff experts will not be deposed until after receipt of the defense expert reports. Defense expert depositions will not be conducted until after completion of plaintiff expert depositions. These provisions may be modified by agreement of the parties or Order.
5. Expert discovery shall be completed by June 13, 2024.

## **II. PRE-TRIAL MOTIONS FOR CMO 74 CASES**

1. Pre-trial motions other than *in limine* (dispositive, Kemp/Accutane) shall be served by July 17, 2024. Consistent with the practice in this MCL, the original motion papers shall be submitted directly to the trial judge's chambers. Only Notices of Motion and Forms of Order shall be submitted for filing with the Clerk's office (either via JEDS or in hard copy).
2. Oppositions to pre-trial motions shall be filed and served by August 22, 2024.
3. Only where necessary, on leave of Court, limited replies shall be filed and served by August 30, 2024.
4. Oral argument on pretrial motions shall be set later by the Court.

## **III. SCHEDULING ORDER FOR CMO 84 CASES**

- A. This Order section applies to the CMO 84 cases attached as Exhibit A.
- B. **FACT DISCOVERY** – Except as otherwise governed by CMOs 95 (regarding friends/ family) and 97 (regarding sales reps), any outstanding fact discovery will be completed by April 15, 2024.

## **IV. ACTIVATION OF CASES**

- A. This order section applies to the cases listed on Exhibit B, which are all activated for discovery.<sup>2</sup>
  1. Any counsel who believes that there is a basis to exempt a case from discovery activation shall notify both liaison counsel

<sup>2</sup> Filed cases that are considered resolved as part of an inventory settlement and for which Defendants await a release are not included on Exhibit B. If Defendants are notified that a plaintiff is rejecting settlement, Defendants will notify the Court within 7 days of Defendants' notification of settlement rejection and will copy that plaintiff's counsel. Upon notification to the Court, the case will be considered activated and the plaintiff must comply with IV.B.1 within 60 days.

(aslater@mazieslater.com and kcrawford@riker.com) by January 11, 2024. The Court will make a determination as to whether the case can be exempt from discovery.

2. Any counsel who believes that there is a basis to include an Exhibit B case under the CMO 84 fact discovery deadline shall notify both liaison counsel (aslater@mazieslater.com and kcrawford@riker.com) by January 11, 2024. If there is an objection to inclusion of a case, the Court will make a determination as to whether the case can be included under the CMO 84 fact discovery deadline.
3. Any counsel who filed a case on Exhibit B within 60 days of the date of this Order shall comply with the below provisions on or before 60 days after the day they filed the case.
4. Any counsel who filed a case on Exhibit B within 6 months of the date of this Order and previously fully complied with the below provisions need not provide any additional information if the Plaintiff for whom they filed has not undergone any mesh revision surgery since compliance.

#### **B. PFS AND MEDICAL AUTHORIZATIONS**

1. In all of the cases identified on Exhibit B, plaintiff shall serve by February 8, 2024 (in accordance with the Ethicon PFS Service Protocols<sup>3</sup>):
  - a. Updated certified PFSs.
  - b. Updated medical authorizations in the forms attached hereto as Addenda A (Marker or LMI as per protocol).

- c. Product identification stickers for all products/ devices implanted to treat either SUI or prolapse, regardless of whether Plaintiff is making a claim in this civil action related to that product/ device.
  - d. Implant operative report(s).
  - e. Operative report(s) for any mesh revision surgery that occurred as of February 8, 2024.
2. Plaintiffs who fail to timely comply with this section of the Order may have their complaint dismissed with prejudice.
  3. Liaison counsel shall meet and confer on or before April 15, 2024 as to a further scheduling order for the plaintiffs listed on Exhibit B who timely complied with this order. Other than as contemplated by IV.A.2, no depositions shall be scheduled until there has been full compliance with this Order.

**IT IS FURTHER ORDERED** that a copy of this Order shall be served upon all counsel within seven (7) days of the date of this Order.
