ORDERED that:

3. If any Plaintiff provides a PFS in accordance with Case Management Order No. 67 after 30 days but within 90 days of entry of this Order, that Plaintiff may move to reinstate their case and pay a \$300 reinstatement fee;
4. If any Plaintiff does not provide a PFS in accordance with Case Management Order No. 67 within 90 days of entry of this Order, Defendants may move to dismiss the case with prejudice.
