It will likely take several months before the settlement will be finalized. As a result, the parties jointly request that this case, which was selected as part of the TVT Exact discovery pool in CMO 74



In the event the global settlement is not finalized, the parties will promptly inform Your Honor so that any such case can be restored to the active docket of this Court.


IT IS on this 18<sup>th</sup> day of November, 2021, **ORDERED** as follows:
