THIS MATTER having come by way of Defendants' Motion for Commissions for Treaters,

Motion to Compel information on the identity Wicker's prescribing physician for Lexapro,

Wicker's treating physician for her 2014 Botox injections, and any other undisclosed treating

ORDERED as follows:

1. Defendants' Motion for the Commission of "Treating" Physicians [Ackerman, Cohen, and Kang] is DENIED.



- Defendants' Motion to Compel information on Wicker's treating physician for her 2014
 Botox injections is DENIED as moot [this information has been provided]. Plaintiff's
 Counsel will speak with Wicker to address the Lexapro issue.
- Defendants' Motion to Compel Wicker's Medical Examination is GRANTED. Counsel shall meet and confer on the logistics of the exam and report back to the Court within 7 days.
- 4. Defendants' Motion to Compel production of photographs from Carrie Wicker's 2014 wedding, Amy Wicker's wedding, 2013 Scotland trip, 2014 boat trip, trips to the Wickers' vacation home in Sea Island, GA, and any other travel photos is GRANTED. Plaintiff shall make these photographs available (in whatever format Plaintiff's Counsel chooses) to a defense counsel representative—for their eyes only. Defense counsel may then pick out three photographs from each event.
- 5. Defendant's Motions concerning Dr. Anne Weber are decided as follows:
 - a. Defendants' Motion to Strike the Supplemental Expert Reports is DENIED.
 - b. Defendants' Motion to Compel an Additional Deposition of Dr. Weber is GRANTED, subject to Counsel meeting and conferring on the scope and the parameters of this deposition.
