- 3. Ms. Bustamante Jones shall notify the Court immediately of any matter affecting her standing at the Bar of any other court;
- 4. Ms. Bustamante Jones shall have all pleadings, briefs, and other papers filed with the Court signed by an attorney of record authorized to practice in this State, who shall be held responsible for them, the conduct of the case, and the attorney admitted herein;
- 5. Ms. Bustamante Jones shall not be designated as trial counsel for purposes of Rule 4:25-4;
- 6. No delay in discovery, motions, trial, or any other proceeding shall occur or be requested by reason of the inability of Ms. Bustamante Jones to be in attendance;
- 7. Ms. Bustamante Jones must, within 30 days, pay the fees required by Rule 1:20-1 and Rule 1:28-2;

8. Automatic termination of <u>pro hac vice</u> admission will occur for failure to make the required annual payment to the Ethics Financial Committee and the New Jersey Fund for Client Protection. Proof of such payment, after filing proof of the initial payment, shall be made no later than February of each year;

9. Noncompliance with any of these requirements shall constitute grounds for removal; and

IT IS FURTHER ORDERED that counsel for Defendants shall serve a copy of this order on all parties within seven (7) days.
