

Zoe Bell v. Ethicon, Inc. et al.

This matter being opened to the court by Amy Ngai, a New Jersey attorney and the attorney of record for plaintiff Zoe Bell to permit Kenneth W. Smith, an attorney admitted to the practice of law in the States of Virginia, Florida, and Mississippi, to participate with other counsel for Zoe Bell in all phases of the litigation and trial, and it appearing that Kenneth W. Smith is a licensed attorney in good standing in the State of Virginia, and it appearing that there has been an attorney/client relationship with the client for an extended period of time and the above case involves a complex field of law in which Mr. Smith has extensive experience;

IT IS ON THIS 29<sup>th</sup> day of May, 2015, **ORDERED** that Kenneth W. Smith be and hereby is admitted *pro hac vice* and is authorized to appear and participate with other counsel for Zoe Bell in all phases of the litigation and trial, subject to the following conditions:



1. Kenneth W. Smith shall abide by the *New Jersey Court Rules* including all disciplinary rules, *R. 1:20-1* and *R. 1:28-2*.
2. Kenneth W. Smith shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his/her agent upon whom service of process may be made for all actions against Kenneth W. Smith that may arise out of his/her participation in the matter.
3. Kenneth W. Smith shall immediately notify the court of any matter affecting his standing at the Bar of any other jurisdiction.
4. Kenneth W. Smith shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.
5. Kenneth W. Smith cannot be designated as trial counsel.
6. No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of Kenneth W. Smith to be in attendance.
7. Kenneth W. Smith must, within ten (10) days, pay the fees required by *R. 1:20-1(b)* and *R. 1:28-2* and submit an affidavit of compliance.
8. *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by *R. 1:20-1(b)* and *R. 1:28-2*.
9. Non-compliance with any of the terms of this order shall constitute grounds for removal.
10. A copy of this order shall be served on all parties within seven (7) days of the date hereof.
