

3. Notify the Court immediately of any matter affecting her standing before this Court; and
4. Have all pleadings and other papers filed in this Court signed by an attorney-at-law of this Court employed by the firm of the Law Offices of Eric H. Weinberg, who shall be responsible for the conduct of James W. Lampkin, II, Esq., and it is further;

ORDERED that James W. Lampkin, II, Esq., shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:28-1(b), 1:28-2 and 1:28b-1(e), within thirty (30) days of the date of this Order, and it is further
