2. Henry G. Garrard, III, Esq. shall, and hereby does, consent to the appointment of the Clerk of the Supreme Court as his agent upon whom service of process may be made

for all actions against Henry G. Garrard, III, Esq. that may arise out of his participation in this matter.

3. Henry G. Garrard, III, Esq. shall immediately notify the Court immediately of any matter affecting his standing at the Bar of any other jurisdiction.

4. Henry G. Garrard, III, Esq. shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in the New Jersey, who shall be held responsible for them, the conduct of the litigation and the attorney admitted herein.
