Fleishman is a member in good standing of the bar of the highest court of the state in which she is domiciled and principally practices law; and for good cause shown.

IT IS on this 11 day of Februare, 2019, hereby

ORDERED that the motion is granted, and that Wendy R. Fleishman is admitted to practice *pro hac vice* before this Court in this matter pursuant to R. 1:21-2, for all purposes and in the same manner as an attorney who is admitted to practice in this State and is domiciled and maintains an office for the practice of law in the State of New Jersey, provided that she shall:

1) abide by the Rules of Courts for the State of New Jersey as adopted by the

IT IS FURTHER ORDERED that Wendy R. Fleishman shall comply annually with the New Jersey Rules of Court, R. 1120-1(b), 1:28-2 and 1:28B-1 (e), and pay the annual required payment to the Ethics Financial Committee and the New Jersey Fund for Client Protection. If she has not done so for this year already, she will make payment within thirty (30) days of the date of this Order.
