**ORDERED** that:

1. Brett Tarver, Esq., a member in good standing of the bar of the Supreme Court of the State of Georgia, be permitted to appear *pro hac vice* in the above-captioned matter and in the matters listed on the attached Schedule A pursuant to R. 1:21-2; and it is

2. **FURTHER ORDERED** that Ms. Tarver shall abide by the New Jersey Court Rules, including all disciplinary rules; and it is
