**STIPULATION AND ORDER OF
VOLUNTARY DISMISSAL, WITHOUT
PREJUDICE, AS TO DEFENDANTS
ROYLE SYSTEMS GROUP, LLC,
ALRABWAH, INC. AND VALBRUNA
STAINLESS, INC., ONLY**

THIS MATTER having come before the Court for a Case Management Conference and the Parties having agreed to the matters herein, it is hereby stipulated and agreed by and between the undersigned parties as follows:




1. All of plaintiffs' claims in the matters set forth in Exhibit A hereto against defendants Royle Systems Group, LLC, Alrabwah, Inc. and Valbruna Stainless, Inc. are hereby dismissed, without prejudice, as are any cross-claims filed by Royle Systems Group, LLC or Alrabwah, Inc. in any of those cases;
2. Notwithstanding the provisions of any prior Order, the dismissal of claims against defendants Royle Systems Group, LLC, Alrabwah, Inc. and Valbruna Stainless,

Inc. pursuant to Orders of Dismissal, dated April 27, 2011, and May 12, 2011, as set forth in Exhibits B and C hereto, respectively, shall remain without prejudice, and that any cross-claims filed by Royle Systems Group, LLC or Alrabwah, Inc. in any of those cases are hereby dismissed without prejudice;


3. Defendants Royle Systems Group, LLC, Alrabwah, Inc. and Valbruna Stainless, Inc. agree to produce and cooperate with Plaintiffs and defendant E.I. DuPont de Nemours and Company (“DuPont”) regarding reasonable discovery requests for so long as this matter shall be before this Court;
4. Based on Plaintiffs’ dismissal of Royle Systems Group, LLC, Alrabwah, Inc. and Valbruna Stainless, Inc., DuPont agrees that it will not seek to remove to federal court the Complaint of any current Plaintiff or the two Complaints of the future Plaintiffs referred to in Paragraph 4 of the Court’s Case Management Order #15. The parties agree to meet and confer about this issue with respect to any other plaintiff; and
5. Based on Plaintiffs’ dismissal of Royle Systems Group, LLC, Alrabwah, Inc. and Valbruna Stainless, Inc., DuPont agrees that it will not assert or attempt to assert that the conduct of defendants Royle Systems Group, LLC, Alrabwah, Inc. and/or Valbruna Stainless, Inc. contributed to Plaintiffs’ alleged injuries or raise or attempt to raise the absence of Royle Systems Group, LLC, Alrabwah, Inc. and/or Valbruna Stainless, Inc. as a defense, set-off or other limitation on liability in connection with any trial or motion in any of the matters consolidated as *In re Alleged Environmental Contamination of Pompton Lakes*, CM Case No. 290.


Plaintiffs and DuPont remain free to refer to Royle Systems Group, LLC, Alrabwah, Inc. and/or Valbruna Stainless, Inc. and facts concerning them in connection with any trial or motion so long as the reference has a purpose other than the purpose identified in the preceding sentence.
