Hewes, Esquire pay the required annual fees to the New Jersey Lawyers' Fund for Client Protection in accordance with New Jersey Rule 1:28-2, the Oversight Committee in accordance with Rule 1:20-1 (b), and the Lawyers' Assistance Program in accordance with Rule 1:28B-1 (e) within ten 10 days of this Order and shall submit an affidavit of compliance; and it is


