CASE MANAGEMENT ORDER No. 2

**THIS MATTER** having come before the court subsequent to the informal case management conference on June 11, 2014, concerning the management of pending New Jersey state cases in the above litigation, and good cause having been shown;

**IT IS** on this 2<sup>nd</sup> day of June, 2014,

**ORDERED** as follows:

1. In accordance with Case Management Order No. 1, dated November 21, 2013, the court dismissed certain pending cases without prejudice.
2. Since Case Management Order No. 1 was issued, additional cases have been dismissed without prejudice by plaintiffs' counsel. A list of the cases dismissed without prejudice as of June 11, 2014 is attached at Exhibit A.
3. No later than **July 18, 2014**, plaintiffs' counsel shall advise defense counsel as to the status of the cases previously dismissed without prejudice.
4. If plaintiffs wish to pursue any of the cases previously dismissed without prejudice, plaintiffs' counsel shall file motions to reinstate those cases no later than **August 6, 2014**.
5. If plaintiffs listed on Exhibit A no longer wish to pursue their claims, defense counsel shall file motions to convert the matters to dismissals with prejudice or counsel may agree on some other mechanism consistent with the New Jersey Court Rules to convert the cases to dismissals with prejudice. Such applications shall be made no later than **August 6, 2014**.
