
IT IS on this 28<sup>th</sup> day of February, 2017, **ORDERED** as follows:

1. No later than June 15, 2017, for all cases in which product identification and alleged injury suffered by plaintiffs are at issue, plaintiffs shall file and serve certifications confirming plaintiffs' ingestion of Propecia® and/or Proscar® for hair loss and identifying the alleged injury suffered as a result of ingestion of these drugs.
2. Defendant may file motions to dismiss plaintiffs' complaints without prejudice for failure to provide Plaintiff Fact Sheets in accordance with CMO 3 in the following cases:
