**ORDER OF DISMISSAL**

**THIS MATTER** having come before the Court at Case Management Conferences including February 7, 2017; March 28, 2017; May 17, 2017; and July 19, 2017, and pursuant to Case Management Orders No. 7, 8 (as amended February 28, 2017) and 12 (paragraph 5)

**IT IS** on this 9<sup>th</sup> day of August, 2017, ORDERED as follows:

1. All Plaintiffs in Propecia Case No. 623, except Wayne Kader (Docket No. MID L-3852-16) and Thomas Strong (Docket No. MID L-3197-16), were required to submit certifications, signed by the individual Plaintiff, confirming his ingestion of Propecia and/or Proscar for hair loss and identifying his alleged injury suffered as a result of ingestion of those drugs.
2. The Court has not received the required certifications for the 11 cases listed in Schedule A. Accordingly, these cases are DISMISSED WITH PREJUDICE for failure to comply with this Court's Orders.
3. Wayne Kader and Thomas Strong have until August 31, 2017 to confirm ingestion of Propecia and/or Proscar for hair loss and identify alleged injuries suffered as a result of ingestion of said drug(s).

**ORDERED** that a copy of this Order shall be served on all parties within 10 days.
