

Handler, (hbreglan@harrisbeach.com and lehandler@pbnlaw.com). Ordinary or other mailing to any Defendant will not be sufficient to effect service of process. Service of process will be deemed complete ten (10) days after mailing in accordance with this Order.

4. The foregoing procedure shall apply to Reglan cases filed in the Superior Court of Atlantic County, New Jersey and not to any other litigation. Defendants reserve all other rights available to them under federal or state law and under applicable treaties and conventions.

5. Ordinary requirements for service of process upon any party not addressed in this Order are unaffected. Except as stated herein, service of process must be effectuated in accordance with New Jersey law.
