**ORDERED AS FOLLOWS:**

1. All parties consent to vacating the court's order dated April 3, 2017;
2. All parties consent to vacating the court's order dated July 31, 2014, dismissing this complaint without prejudice;

3. This complaint is reinstated.
4. The caption of the reinstated complaint shall be amended to “Donna Minnerick as Executrix of the Estate of Carolyn Minnerick.”
5. The amended complaint shall be filed within fourteen (14) days of the date of this order.
6. Defendants PLIVA, Inc., individually and F/K/A Sidmak Laboratories, Inc. and Watson Laboratories, Inc. are deemed served for settlement purposes only under Rule 1:13-7.
7. If settlement is not achieved, then service of the summons and amended Complaint shall be made in strict compliance with CMO Nos. 3, 6 and the CMO regarding Service of Process entered on October 29, 2010.
8. Counsel for defendants PLIVA, Inc., individually and F/K/A Sidmak Laboratories, Inc., and Watson Laboratories, Inc. do not waive any applicable affirmative defenses.
