**IT IS** on this 13 day of June hereby



3. notify the Court immediately of any matter affecting his standing at the bar of any Court; and
4. have all pleadings, briefs and other papers filed in this Court signed by an attorney-at-law of this Court employed by the law firm of Dechert LLP, who shall be responsible for them, for the conduct of the cause and of Joshua S. Stambaugh, Esq., it is further

**ORDERED** that Joshua S. Stambaugh, Esq. shall make payment of fees as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2 and 1:28B-1(e) and it is further

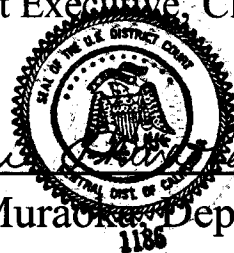
