THIS MATTER having come before the Court on February 9, 2010 concerning the case management of all pending New Jersey state cases in the above-captioned litigation, and good cause having been shown;

IT IS on this 16th day of FEBRUARY, 2010 *effective from the conference date;*

ORDERED as follows:

1. As to Patricia Buie (L-213-07) and Tom Sever (L-1741-07), plaintiffs' counsel shall provide a date for plaintiffs' depositions within seven (7) days. Plaintiffs' depositions shall be conducted by **March 9, 2010**.
2. Any and all outstanding depositions of treaters and prescribers in Group 2 cases shall be completed by **April 15, 2010**.
