THIS MATTER having been opened to the court jointly by counsel for defendants Johnson & Johnson and Janssen Pharmaceuticals, Inc. (f/k/a Ortho-McNeil-Janssen Pharmaceuticals, Inc., f/k/a Janssen Pharmaceutica, Inc.) (hereinafter the "Janssen defendants") and counsel for the Sheller plaintiffs for the above referenced trial cases; and counsel for the parties having conferred as to form and substance of this order; and counsel for the parties having agreed to adjust the dates established in CMO 56A; and for good cause shown,

IT IS on this 5th day of October 2012,

ORDERED as follows:

- 1. Janssen defendants' expert reports in the above referenced trial cases shall be provided no later than November 16, 2012.
- 2. Depositions of experts in the above referenced trial cases shall be completed no later than December 14, 2012.
- 3. Expert discovery shall be conducted pursuant to the "Joint Stipulation Regarding Expert Discovery" entered by the parties in June 2011.
- 4. All dispositive motions in the above referenced trial cases shall be filed and served according to the following schedule:

- (a) Motions: no later than September 21, 2012.
- (b) Oppositions: no later than **November 2, 2012**.
- (c) Replies: no later than November 9, 2012.
- (d) Oral argument: to be scheduled by the court if necessary.
- 5. All motions relating to the admissibility of expert testimony (Kemp/Rule 702) in the above referenced trial cases shall be filed and served according to the following schedule:
 - (a) Motions: no later than January 4, 2013.
 - (b) Oppositions: no later than January 18, 2013.
 - (c) Replies: no later than January 25, 2013.
 - (d) Oral argument: to be scheduled by the court if necessary.
- (e) Any <u>Kemp/Rule</u> 702 hearings deemed necessary by the court to be held on dates to be scheduled between **January 28, 2013** and **February 1, 2013**.
- 6. All <u>in limine</u> motions in the above referenced trial cases shall be filed and served according to the following schedule:
 - (a) Motions: no later than February 1, 2013.
 - (b) Oppositions: no later than February 8, 2013.
 - (c) Oral argument: to be scheduled by the court if necessary.
 - 7. On or before **February 27, 2013**, the court shall a case for trial.
- 8. The schedule for the exchange and submission of deposition designations in the court selected trial case shall be as follows:

- (a) Counsel to exchange proposed deposition designations by March 13, 2013.
- (b) Counsel to exchange objections to deposition designations and counter designations by March 20, 2013.
- (c) Counsel to meet and confer regarding deposition designations during the week of March 25, 2013.
- (d) Counsel to submit written objections to the court as to any unresolved deposition designations no later than March 29, 2013.
- 9. The schedule for the exchange and submission of proposed exhibit lists and witness lists for the court selected trial case shall be as follows:
- (a) Counsel to exchange proposed exhibit lists and witness lists no later than April 5, 2013.
- (b) Counsel to serve objections to proposed exhibit lists and witness lists no later than April 12, 2013.
- (c) Counsel to submit final exhibit lists and witness lists to the court no later than April 17, 2013.
- 10. A one page joint statement of the case for the jury pool, joint submissions of questions for the jury voir dire, proposed jury charges and proposed verdict sheet shall be submitted to the court no later than April 17, 2013.
- 11. All of the aforementioned documents to be filed with the court shall be filed by 12:00 p.m. on the date due.

- 12. Trial in the selected case will commence on April 29, 2013.
- 13. A copy of this order shall be posted on line by the court within seven (7) days of the date of this order.
