CASE MANAGEMENT ORDER NO. 65

THIS MATTER having come before the court on November 29, 2012, concerning the case management of all pending New Jersey state cases in the above-captioned litigation, and good cause having been shown;


IT IS on this 29th day of **November, 2012**:

ORDERED as follows:

1. No later than **December 5, 2012**, counsel for plaintiff Estate of Pickney, Docket No. L-5044-11, shall file a motion to reinstate the complaint. The motion to reinstate shall be returnable no earlier than **December 21, 2012**.
2. Provided that an order reinstating the complaint is granted on or about December 21, 2012, then no later than **December 26, 2012**, counsel for plaintiff Estate Pickney, Docket No. L-5044-11, shall file a motion to amend the complaint naming a proper legal representative to prosecute this matter on behalf of the estate.
3. If counsel for plaintiff Estate Pickney, Docket No. L-5044-11, fails to comply with the requirements of Paragraph 1 and/or Paragraph 2 of this order, counsel for defendant Janssen shall be permitted to file a motion to dismiss the complaint with prejudice.
4. No later than **December 19, 2012**, counsel for plaintiff John Graham, Docket No. L-501-07, shall provide proof that appropriate action is being taken to appoint a proper legal representative to prosecute this matter on behalf of the estate.
5. No later than **November 30, 2012**, counsel for plaintiff Beverly Day, Docket No. L-9117-06, shall provide a certification regarding that status of her "grateful journal."
6. Counsel for defendant Janssen shall be permitted to file motions to dismiss the plaintiffs' complaints without prejudice in the following cases:
 - a. Peter Drozd, Docket No. L-9101-06; and
 - b. James Quaglietta, Docket No. L-5476-09.

The motions shall be returnable no earlier than **December 21, 2012**.

7. No later than **December 6, 2012**, counsel for plaintiff Estate of Emma Bragg, Docket No. L-9102-06, shall pay to counsel for defendant Janssen the “costs” incurred in conducting plaintiff’s deposition in Ohio.
8. The depositions of plaintiffs’ causation experts in the Sheller firm’s bellwether cases shall be completed no later than **December 25, 2012**.
9. Counsel for plaintiff Max Apel, Docket No. L-10623-09, shall provide causation expert report(s) as to the allegations against the pharmaceutical defendants no later than **January 23, 2013**.
10. The next case management conference shall be conducted on **January 8, 2013** at **10:00 a.m.** in **courtroom 403**. Any joint agenda items and submissions shall be submitted to the court by **noon** on **January 1, 2013**.
11. The court shall post a copy of this order on line within seven (7) days of the date of this order.
