

7. The deadline for the completion of OMJP, Inc. company witness depositions is hereby extended until **July 31, 2009**.
8. Defendant Janssen may file a motion to quash plaintiffs' deposition notice for a Janssen corporate designee / records custodian regarding collection and production of records, including records of Belgian employees. The filing date of the motion shall be **June 10, 2009**, returnable on **June 26, 2009**.
9. The next Case Management Conference is scheduled on **June 24, 2009 @ 10:00am**. Any joint agenda items and submissions shall be submitted to the Court by noon on **June 17, 2009**.
