**ORDER**

THIS MATTER being opened on the Court's own motion and for good cause shown;

IT IS ON THIS 17<sup>m</sup> day of July, 2014,

ORDERED that for each plaintiff listed in Exhibit A plaintiffs' counsel shall provide counsel for the Johnson & Johnson and Janssen (hereinafter "Janssen") defendants with a certification, attached hereto, wherein each plaintiff represents that he or she (or, for wrongful death claims or survivor claims, the Claimant's decedent, or for loss of consortium claims, the Claimant's relative), was (i) prescribed and took Risperdal<sup>®</sup> and specify the dates of Risperdal<sup>®</sup> use; (ii) was diagnosed with diabetes or a diabetes-related medical condition.


IT IS FURTHER ORDERED that each plaintiff listed in Exhibit A shall provide defendants with a certification, attached hereto, within sixty (60) days of the date of this Order.

IT IS FURTHER ORDERED that within 10 days after the expiration or the period for plaintiffs' counsel to provide the required certifications to Janssen's counsel, plaintiffs' counsel shall file a report with the Court setting forth any plaintiffs for whom it was unable to provide the required certification. The claims of those plaintiffs for whom no certification was provided are, by this Order, dismissed without prejudice.

IT IS FURTHER ORDERED that all said plaintiffs shall be given an additional sixty (60) days, from the date of the dismissal without prejudice Order, to serve the attached certification at which point the case will be reinstated.

IT IS FURTHER ORDERED that within 10 days after the expiration of such 60 day period, plaintiffs' counsel shall file an updated report and certification as to those plaintiffs whom plaintiffs' counsel have been unable to provide the required certification, setting forth counsel's diligent inquiry and efforts to contact said plaintiffs. As to those plaintiffs who still have not provided the required certification, their cases are, by this order, dismissed with prejudice and the Court shall issue a judgment of dismissal with prejudice.

IT IS FURTHER ORDERED that plaintiffs' counsel shall serve a copy of this Order upon each Plaintiff's last known address by certified and regular mail, within 7 days of the entry hereof.
