ORDERED that, upon being served with the within order of dismissal without prejudice, plaintiffs' counsel shall forthwith serve a copy of this order on plaintiffs by regular and certified mail, return receipt requested, accompanied by a notice in the form prescribed by Appendix II-F of the New Jersey Rules of Court, specifically explaining the consequences of failure to file and serve a timely motion to restore.
