

(f/k/a Ortho-McNeil-Janssen Pharmaceuticals, Inc., f/k/a Janssen Pharmaceutica, Inc.) and Johnson & Johnson, who were erroneously designated in the Complaint as Johnson & Johnson Company and Janssen Pharmaceutica Products, L.P., pursuant to Case Management Order No. 4A; and it is further

ORDERED that, in the event that plaintiff fails to vacate this Order on or before January 20, 2015, Defendants may move for an Order of Dismissal with prejudice pursuant to the procedure set forth in R. 4:23-5(a)(2); and it is further
