

IT IS on this 24 day of June, 2009, **ORDERED**:

1. That solely for the purposes of this case, and without prejudice to choice-of-law issues governing any other cases, the state-law claims in this case will be governed by New Jersey law; *the parties consent to and waive their right to appeal as to this issue*
2. That this Consent Order is entered without prejudice to the parties' rights to take and argue different positions regarding choice of law in other cases pending before this Court, or elsewhere.
3. That this Consent Order may be signed in multiple counterparts, and the separate signature pages executed by the Parties may be combined to create a document binding on all Parties and together shall constitute one and the same instrument.
4. That McCarter and English LLP shall serve a copy of this Order on all Counsel within 7 days of the entry of this Order.


