ORDERED that, in the event that plaintiff fails to vacate this Order ~~on or before August 28, 2012~~, Defendants may move for an Order of Dismissal with prejudice pursuant to the procedure set forth in R. 4:23-5(a)(2); and it is further


ORDERED that a signed copy of this Order be posted for all counsel within 7 days of the date hereof.
