This Matter having been assigned to the Honorable Brian R. Martinotti, J.S.C., pursuant to the Supreme Court's Order of January 24, 2013, designating this matter for Multicounty Litigation Status ("MCL") of Stryker Rejuvenate & ABG II Modular Hip Implant Litigation (hereinafter referred to as "Stryker") [a Multidistrict Litigation ("MDL") pending before the Honorable Donovan W. Frank, USDJ], and the Court having reviewed the proposed agenda, conducting a CMC on October 8, 2015, counsel appearing, for good cause shown and for the reasons set forth on the record,

IT IS on this 8th day of October 2015,

ORDERED:

I. CONSIDERATION OF PRIOR MOTIONS:

1. Defendant Howmedica Osteonics Corp.'s ("HOC") Motion to Dismiss with Prejudice the claims of Plaintiffs listed on Exhibit A and Exhibit B, which was brought

pursuant to the terms of the Master Settlement Agreement signed by the parties on November 3, 2014 and amended on July 1, 2015, is GRANTED.

II. CASE MANAGEMENT

1. **Settlement Update:** Counsel advised that over 95 percent of the 95 percent of the cases that have been settled have been fully funded by HOC to Plaintiffs' escrow agent for the base awards.
2. **Discovery Status:** Counsel shall continue to meet, confer, and cooperate with each other and the MDL and other coordinated jurisdictions on their continuing discovery obligations.
3. **Registration Process:** Counsel to meet and confer and submit an updated Registration/Census Order [for both filed and unfiled cases] to the Court within 30 days.
4. **Motion for Payment of Lien Resolution Costs:** An order will be submitted today.
5. **Duplicate Filings:** Counsel to meet and confer to address the issue of duplicate filings either in duplicate jurisdictions or for multiple firms filing for the same plaintiffs in New Jersey.

III. GENERAL:

1. Counsel will select a date and time for the next Case Management Conference.
Counsel shall submit a proposed agenda seven (7) days prior to this Case Management Conference.

2. As of *Pro hac vice* motions shall not be filed until complaint is filed and served on Defendants.
3. The official record shall be the transcript provided by the court reporter retained by counsel. The reporter shall preserve all proceedings and shall email a transcript of any court proceeding to the court within 14 days of the proceeding.
4. Subject to agreement by and between counsel and with permission from the Court, counsel is permitted to appear telephonically; in order to have your appearance on the record, it is counsel's responsibility to Email liaison counsel and the court reporter at least one hour before the proceeding with your name, firm, and party representing, indicating that you intend to appear by phone; in addition you must confirm your appearance, immediately following the proceeding. Absent the above, counsel's appearance will not be noted.
5. By consent of all parties, the court may contact or be contacted on an *ex parte* basis regarding settlement issues only.
6. The court may, from time to time, conduct phone conferences with defense counsel and liaison counsel.
7. The Court directs all counsel to R. 1:4-8 and expects all counsel to abide by the parameters set forth therein.
8. All Court proceedings will start at the designated scheduled time. Counsel is expected to arrive promptly for these proceedings.
9. Counsel shall provide the Court with their preferred e-mail address by e-mailing same to Kelly Gibson at Kelly.Gibson@judiciary.state.nj.us and Stephanie Gino at Stephanie.Gino@judiciary.state.nj.us.

10. Counsel shall copy their co-counsel and all adversaries on all e-mails and other electronic correspondence submitted to the Court [COUNSEL IS PROHIBITED FROM FILING ANY PLEADING ELECTRONICALLY]. Any such submission received after 4:30 p.m. will be deemed received at 9:00 a.m. on the next day Court is in session. Any such submission received after 4:30 p.m. on a Friday or over a weekend, will be deemed received on 9:00 a.m. on the next day Court is in session.
11. Counsel is directed to contact The Superior Court of New Jersey, Attorneys Accounts: P.O. Box 980, Hughes Justice Complex, 25 W. Market Street, Trenton, New Jersey 08625, (609) 633-8643 to establish a collateral account for any filing fees within seven (7) days.
