**This Matter** having been assigned to the Honorable Brian R. Martinotti, J.S.C., pursuant to the Supreme Court's Order of January 24, 2013, designating this matter for Multicounty Litigation Status ("MCL") of Stryker Rejuvenate & ABG II Hip Implant Litigation (hereinafter referred to as "Stryker") [of note is the Federal Joint Panel on Multidistrict Litigation has assigned this matter to Judge Donovan W. Frank in the D. Minnesota], and the Court having reviewed the proposed agenda, conducting a CMC on June 18, 2013, counsel appearing, for good cause shown and for the reasons set forth on the record,

**IT IS** on this 26th day of June 2013,

**ORDERED,**

**I. COMPLIANCE WITH PRIOR ORDERS:**

1. ORDERS ENTERED SINCE CMO #5:

None.

2. COMPLIANCE:

A. Counsel have met and are continuing to meet on the following:

[Counsel's request to extend this time set forth in CMO #5 is GRANTED.]

- i. Plaintiffs' Fact Sheet: **Complete.**
- ii. Defendants' Fact Sheet: **To be discussed at meet and confer on July 2, 2013.**
- iii. Scope, parameters and timing for service of written discovery: **Parties may serve discovery requests compliant with court rules and shall continue to meet and confer regarding discovery.**
- iv. Protective Order: **To be discussed at meet and confer on July 2, 2013.**

**II. DISCOVERY**

1. Deposition Guidelines for Plaintiffs who are in extremis: Parties to meet and confer regarding an order on July 2, 2013.
2. Written Discovery (including insurance disclosures and DFS):
  - a. Defendants to produce a chart setting forth insurance coverage information and declaration sheets within ten (10) days (premiums to be redacted);
  - b. Defendants to produce one ESI witness for deposition and one corporate structure witness for deposition requests by August 7, 2013;

- c. Parties to meet and confer to discuss a phase in for Defendants' Fact Sheet and discovery on July 2, 2013.
3. Form of Production of Fact Sheet-Related Records: All records shall be produced on a compact disc (CD) all to be bated stamped in a format as follows:
  - a. Plaintiff's first initial-Plaintiff's last name-bate stamp #
4. Medical Records authorization/vendor status: Defendants to select a vendor and provide names to Plaintiff on July 2, 2013.

### **III. CASE MANAGEMENT:**

1. All new complaints shall be served within thirty (30) days of receipt of a filed copy from the Court.
2. Cases for Mediation will be chosen as follows:
  - a. Six (6) cases randomly selected by the Court
  - b. Two (2) cases selected by Plaintiffs
  - c. Two (2) cases selected by Defendants
3. Plaintiffs who have elected to be eligible to participate in Phase I Mediation as set forth in the Initial Mediation Order shall serve completed Fact Sheets on Defendant and Liaison Counsel no later than July 10, 2013.
4. Plaintiffs not referenced in paragraph (2) above who served their complaints prior to entry of this Order shall serve completed Fact Sheets on Defendants and Liaison Counsel by August 12, 2013.
5. All other Plaintiffs shall serve completed Fact Sheets on Defendant and Liaison Counsel within sixty (60) days of service of the complaint.

6. Parties are required to comply with CMO #3 regarding the service of preliminary disclosure forms. (See CMO #3, paragraph (I)(2)(A)(i).)
7. ESI Protocol and Scheduling Meet and Confer: Counsel shall meet and confer on July 1, 2013.
8. Status of Stipulation regarding Stryker Corporation and Stryker Ireland: Parties shall submit a proposed order/stipulation with all agreed upon changes to the Court within seven (7) days.
9. Discussion Regarding Exemplar Products:
  - a. Defendant shall investigate the “universe” of exemplars that exist and provide type, size, quantity, and whether packaged or unpackaged to Plaintiffs and the Court within 30 days.
  - b. Once the above is produced, Parties will have a telephone conference with the Court concerning production.
10. File & Serve Service: pending proposal

#### **IV. GENERAL:**

1. The next Case Management Conferences are scheduled for July 17, 2013, and August 13, 2013, at 10:00am. **Counsel shall submit a proposed agenda seven (7) days prior to this Case Management Conference.**
2. *Pro hac vice* motions shall not be filed until complaint is filed and served on Defendants.

3. The official record shall be the transcript provided by the court reporter retained by counsel. The reporter shall preserve all proceedings and shall email a transcript of any court proceeding to the court within 14 days of the proceeding.

4. Subject to agreement by and between counsel and with permission from the Court, counsel is permitted to appear telephonically; in order to have your appearance on the record, it is counsel's responsibility to Email liaison counsel and the court reporter at least one hour before the proceeding with your name, firm, and party representing, indicating that you intend to appear by phone; in addition you must confirm you appearance, immediately following the proceeding. Absent the above, counsel's appearance will not be noted.

5. By consent of all parties, the court may contact or be contacted on an *ex parte* basis regarding settlement issues only.

6. The court may, from time to time, conduct phone conferences with defense counsel and liaison counsel.

7. The Court directs all counsel to R.1:4-8 and expects all counsel to abide by the parameters set forth therein.

8. All Court proceedings will start at the designated scheduled time. Counsel is expected to arrive promptly for these proceedings.

10. Counsel shall copy their co-counsel and all adversaries on all e-mails and other electronic correspondence submitted to the Court [COUNSEL IS PROHIBITED

FROM FILING ANY PLEADING ELECTRONICALLY]. Any such submission received after 4:30 p.m. will be deemed received at 9:00 a.m. on the next day Court is in session. Any such submission received after 4:30 p.m. on a Friday or over a weekend, will be deemed received on 9:00 a.m. on the next day Court is in session.
