Martinotti, J.S.C. pursuant to the Supreme Court's Order of January 24, 2013, designating this matter for Multicounty Litigation Status ("MCL") of Stryker Rejuvenate & ABG II Modular Hip Implant Litigation (hereinafter referred to as "Stryker") [a Multidistrict Litigation ("MDL") pending before the Honorable Donovan W. Frank, USDJ], and having come before the Court on the Motion of defendant Howmedica Osteonics Corp. ("HOC") for an order dismissing Plaintiffs' Complaints with prejudice in furtherance of the private Settlement Agreement under which these plaintiffs' claims have been resolved, and the parties, having stipulated to the dismissal of these plaintiffs' claims with prejudice, the following order is hereby entered:
