
**ORDER ADMITTING G. SEAN JEZ, ESQ.**  
***PRO HAC VICE***

Sean Jez, Esquire is a licensed attorney in good standing in the State of Texas, and it appearing that there is good cause for *pro hoc vice* admission being that there has been an attorney/client relationship with the client for an extended period of time,

IT IS ON THIS 5<sup>th</sup> day of September, 2014, ORDERED, that G. Sean Jez,

Esquire be and hereby is admitted *pro hac vice* and is authorized to appear and participate with other counsel for Plaintiffs in all phases of the case subject to the following conditions:

- (1) G. Sean Jez, Esquire must abide by the Rules governing the courts of the State of New Jersey, including disciplinary rules, R. 1:20-1 and R. 1:28-2.
- (2) G. Sean Jez, Esquire, shall and hereby does consent to the appointment of the Clerk of the Supreme Court as agent, upon whom service of process may be made for all actions him or his firm that may arise out of his participation in this matter;
- (3) G. Sean Jez, Esquire must within ten (10) days, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit and affidavit of compliance;
- (4) G. Sean Jez, Esquire shall immediately notify the Court of any matter affecting their standing at the bar of any court;
- (5) G. Sean Jez, Esquire shall have all pleadings, briefs and other papers filed with the court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for said papers and the conduct of the cause, as well as being held responsible for the conduct of the admitted attorney herein;
- (6) G. Sean Jez, Esquire cannot be designated as trial counsel;
- (7) No discovery, motion, trial or any other proceeding delay shall occur or be requested by reason of the inability of G. Sean Jez, Esquire to be in attendance;
- (8) *Pro hac vice* admission will automatically terminate for failure to make the initial and any annual payment required by R. 1:20-1 (b) and R. 1:28-2;
- (9) Non-compliance with any of the terms of this order shall constitute grounds for removal; and,
- (10) A copy of this order shall be served on all parties with seven (7) days of the date hereof.
