**THIS MATTER** having been presented to the Court upon the application of Schiffman, Abraham, Kaufman & Ritter, P.C., local counsel for the plaintiff, Robert Earl Smith, upon notice to all interested parties, having moved before this Court for admission *Pro Hac Vice* of Charles Mindlin, Esq., the Court having considered the papers in support thereof; and the Court having found that Charles Mindlin, Esq., is a member in good standing of the Bar of the highest Court in the State where he principally practices law; and with good cause shown;

IT IS on this 12 day of JULY, 2013

**ORDERED** that Charles Mindlin, Esq., be and hereby is permitted to practice before this Court *Pro Hac Vice* on behalf of the plaintiff, Robert Earl Smith, to the same extent as a member of this Court and an attorney of this State pursuant and subject to the limitations as set forth in R. 1:21-2; and it is further

**ORDERED** that Charles Mindlin, Esq. shall abide by the Rules of Court for the State of New Jersey, including all disciplinary rules, *R. 1:20-1* and *R. 1:28-2*; and it is further

**ORDERED** that Charles Mindlin, Esq. shall notify the Court immediately of any matter affecting his standing at the Bar of any other jurisdiction; and it is further

**ORDERED** that Charles Mindlin, Esq. shall have all pleadings, briefs and other papers filed with the Court signed by an attorney of record authorized to practice in this State, who shall be held responsible for them and for the conduct and cause of Charles Mindlin, Esq.; and it is further

**ORDERED** that Charles Mindlin, Esq. shall be required to pay the New Jersey Lawyers' Fund for Client Protection, as required by all New Jersey attorneys pursuant to *R. 1:28-1*, and he agrees to make said contribution for subsequent years when they are due; and it is further

**ORDERED** that Charles Mindlin, Esq. shall consent to the appointment of the Clerk of the Superior Court as an agent upon whom service of process may be made for all actions against him and his firm that may arise out of his participation in this matter; and it is further

**ORDERED** that the admission of Charles Mindlin, Esq. shall not be cause for any adjournment in this matter; and it is further

**ORDERED** that Charles Mindlin, Esq. shall make payment of all fees due to the State of New Jersey within 30 days of the entry of the *Pro Hac Vice* Order allowing for admission and as provided in the New Jersey Rules of Court, *R. 1:20-1*, *1:28-2* and *1:28B-1(e)*; and it is further

**ORDERED** that a copy of this Order shall be served by attorneys for Plaintiff upon the Defendant within seven (7) days of the receipt thereof.
