**ORDERED**, that ROBERT B. SICKELS, shall be required to pay the New Jersey Lawyers' Fund for Client Protection, as required by all New Jersey attorneys pursuant to R. 1:28-1, and he agrees to make said contribution for subsequent years when they are due; and it is further
