
IT IS on this 18th day of November, 2022,

ORDERED as follows:

1. The Court GRANTS Defendant's Motion to Dismiss without prejudice for failure to timely serve the required authorization with Plaintiff Fact Sheet.
2. Plaintiffs' complaint and all claims against All Defendants in the actions listed on Schedule A are hereby dismissed without prejudice.
3. Regarding paragraph 2 above, pursuant to Section E of Case Management Order, Plaintiffs shall have thirty (30) days from the date of this Order to serve upon Defendant the required authorizations in pursuant to Case Management Order No. 3 and move before this Court for reinstatement of the Complaint and payment of the appropriate fee.
4. Any refile of this action must occur in New Jersey Superior Court;

5. In the event of Plaintiffs' failure to comply with paragraph 3 above, this dismissal without prejudice will be converted to a dismissal with prejudice upon Defendant's motion

6. Service of this Order shall be deemed effectuated upon all parties upon its upload to e-Courts.
