TODD R. FRIEDMAN ADMISSION TO
PRACTICE *PRO HAC VICE***


THIS MATTER having been opened before the Court by Parker Waichman LLP, attorneys for Plaintiff *Teresa Dalton*, for an Order Granting of Motion for Admission of Todd R. Friedman to Practice *Pro Hac Vice*, and the Court having considered the moving papers and any opposition thereto, and for good cause shown;

IT IS on this 14th day of July, 2021,

1. Melanie Muhlstock, an attorney of the State of New Jersey, moved under New Jersey Rule of Court 1:21-2 for admission *pro hac vice* of Todd R. Friedman, an attorney of the state of Florida, in the above-captioned matter. The certification of Todd R. Friedman indicates that he satisfies the conditions for admission, including good cause, set forth in Rule 1:21-2(a) and that payment has been made or within 10 days hereof will be made to the New Jersey Lawyers' Fund for Client Protection and Ethics Financial Committee.

2. Therefore, it is **ORDERED** that Plaintiff's motion seeking the admission of Todd R. Friedman to practice *pro hac vice* in the above-referenced matter is hereby **GRANTED**, provided that Todd Friedman shall:

- a. Abide by the Rules Governing the Courts of the State of New Jersey, including all Disciplinary Rules, R. 1:20-1 and R. 1:28-2;
- b. Consent to the appointment of the Clerk of the Supreme Court as the agent upon whom service of process may be made for all actions against me that may arise out of my participation in this matter;
- c. Have the continuing obligation during the period of such admission immediately to notify the Court of any matter affecting my standing at the Bar and of a disposition made of pending charges or of the institution of new disciplinary proceedings of any other jurisdiction;
- d. Have all pleadings, briefs and other papers filed with this Court signed by an attorney of record authorized to practice in New Jersey, who shall be held responsible for them, the conduct of the litigation, and I, the attorney admitted herein;
- e. Not be designated as trial counsel;
- f. Within ten (10) days, pay the fees required by R. 1:20-1(b) and R. 1:28-2 and submit an affidavit of compliance; and
- g. Terminate *pro hac vice* admission automatically for failure to make the initial and any annual payment required by R. 1:20-1(b) and R. 1:28-2.
