**CASE MANAGEMENT ORDER NO. 3**

**THIS MATTER** having come before the Court for a Case Management Conference on February 27, 2019, and the parties having met and conferred; and for good cause shown:

IT IS on this 17<sup>th</sup> day of April, 2019, **ORDERED** as follows:

1. The Parties shall meet and confer as to the scope of the Defendant Fact Sheet by March 11, 2019. If a resolution cannot be reached, the Parties shall submit a single redline and corresponding submissions setting forth their positions on the paragraphs in dispute by March 11, 2019.
2. On or before March 22, 2019, the Parties shall meet and confer to discuss the following:
  - a. Defendants' responses to Plaintiffs' discovery requests served on October 3, 2018;
  - b. To determine a protocol and date on or before June 15, 2019, for Science Day to occur;



- c. The documentary evidence that was produced pursuant to the Court's January 23, 2019 Product Identification Order, and a protocol for the production of documentary evidence for the Plaintiffs who have not provided documentary evidence of proof of use and/or manufacturer identification pursuant to the Court's January 23, 2019 Product Identification Order;
  - d. Deadlines and procedure for Defendants to dispute the documentary evidence produced by Plaintiffs pursuant to the Court's January 23, 2019 Product Identification Order;
  - e. The submission of a proposed Order concerning the parties' obligations and the procedures governing the discovery of Product Identification Information; and
  - f. Proposed Streamline Service Orders for Defendants McKesson, Sagent and Sanofi.
3. Absent other agreement or Court Order, and subject to the parties' meet and confer held pursuant to Paragraph 2(a) of this Order, within sixty (60) days from the entry of the latter of the ESI Protocol, Protective Order and the Court's decision concerning Defendants' Partial Motion to Dismiss, the Defendants will respond to Plaintiffs' Discovery Requests served on October 3, 2018, with the exception of Defendants McKesson and Sun Pharmaceutical.
4. The next Case Management Conference is scheduled for April 18, 2019 at 10:00 a.m. before the Undersigned in Courtroom 403 at the Middlesex County Courthouse, 56 Patterson Street, New Brunswick, New Jersey. Liaison Counsel for the parties shall circulate a dial-in to all counsel of record and the Court prior to the

conference. The Parties shall submit a joint agenda to the Court listing the issues for the case management conference, via e-mail, by 12:00 PM on April 11, 2019. Short explanatory paragraphs are permitted. On or before April 4, 2019, Defendants will provide the Plaintiffs with the proposed draft agenda.

5. The official record shall be the transcript provided by the Court reporter retained by counsel. The reporter shall preserve all proceedings and shall email a transcript of any Court proceeding to the court within fourteen (14) days of the proceeding.
