**STIPULATION OF DISMISSAL WITH PREJUDICE**



C.R. 4:37-1, all parties to this action, by and through the undersigned counsel, hereby agree to the dismissal with prejudice of Defendants SANOFI U.S. SERVICES, INC., formerly known as SANOFI-AVENTIS U.S., INC., SANOFI-AVENTIS U.S., LLC, separately doing business as WINTHROP U.S., and SANDOZ INC.

Accordingly, it is hereby stipulated and agreed by and between the undersigned counsel that this matter is hereby dismissed with prejudice and without costs against any party.




