
1. abide by the Rules of Court for the State of New Jersey including all disciplinary rules;

2. consent to the appointment of the Clerk of the Supreme Court as an agent upon whom service of process may be made for all actions against her and her firm that may arise out of his participation in this matter;
3. notify the Court immediately of any matter affecting his standing before this Court; and
4. have all pleadings and other papers filed in the Court signed by an attorney-at-law of this Court employed by Napoli Shkolnik PLLC who shall be responsible for the conduct of Frederick B. Darley, III; and it is further

ORDERED that Frederick B. Darley, III shall make payment of all fees due to the State of New Jersey within 30 days of the entry of the pro hac vice Order allowing for admission and as provided in the New Jersey Rules of Court, Rule 1:20-1(b), 1:28-2, and 1:28B-1(e); and it is further
