IT IS on this __19th __ day of __February ______, 2021, hereby **ORDERED** that the motion is granted, and Monika I. - 5. not be designated as trial counsel and must be accompanied by a member of the New Jersey bar for all proceedings, unless specifically waived by the Court.

IT IS FURTHER ORDERED that Monika I. Jasiewicz, Esquire, shall make payment of all fees due to the State of New Jersey within thirty (30) days of the entry of the pro hac vice Order allowing for admission and as provided in the New Jersey Rules of Court, R. 1:20-1(b), 1:28-2, and 1:28B-1(e).

IT IS FURTHER ODERED that *pro hac vice* admission in the State of New Jersey shall automatically terminate for failure to make the initial payment required by R. 1:20-1(b), R. 1:28-1, and R. 1:28-2.

IT IS FURTHER ORDERED that service of this Order shall be deemed effectuated upon all parties upon its upload to e-Courts. Pursuant to <u>Rule</u> 1:5-1(a), movant shall serve a copy

of this Order on all parties not served electronically within seven (7) days of the date of this Order.
